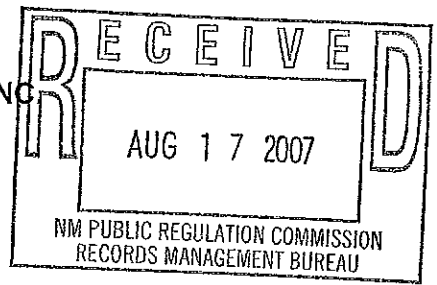

APPLICABILITY:

Available to all consumers engaged in commercial pumping, three-phase or who are not on demand instrumentation.

TERRITORY:

All residential service in Roosevelt County, extending in portions of Curry, Lea, Chaves and De Baca counties.

CHARACTER OF SERVICE:

Alternating current, 60 Hertz, at available secondary voltages.

MONTHLY DISTRIBUTION RATE:

TAX ADJUSTMENT:

Billings under this schedule may be increased by an amount equal to the sum of taxes payable under the Gross Receipts and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of advalorem, state, and federal income taxes) payable by the utility and levied or assessed by any government authority on the public utility service rendered, or on the right or privilege of rendering the service, or any other object or event incidental to the rendition of the service.

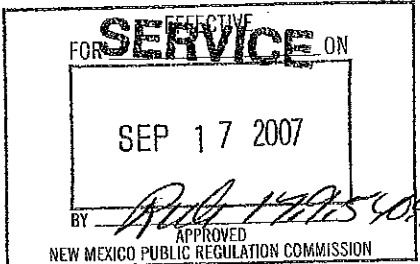
IDLE SERVICE RATE:

Consumers classified under this rate schedule may retain existing electric facilities (disconnected) on their premises by paying 60% of the established monthly minimum bill each month thereafter.

MINIMUM CHARGES:

The monthly minimum charge under this schedule shall be \$2.00/HP/Month, but not less than \$20.00/Month.

The monthly minimum charge specified herein shall not be less than established in accordance with the Cooperative's Line Extension Policy.

FUEL AND PURCHASED POWER COST ADJUSTMENT:

Billings under this schedule shall be increased or decreased by any amount that the purchased power cost for the previous month differs from \$.057816/KWH sold, in accordance with NMPRC Rule No. 550. X

SURCHARGE:

Billing under this schedule shall have a surcharge of 1% in order to procure renewable energy, invest in renewable energy projects or promote energy conservation and load management. X

TERMS OF PAYMENT:

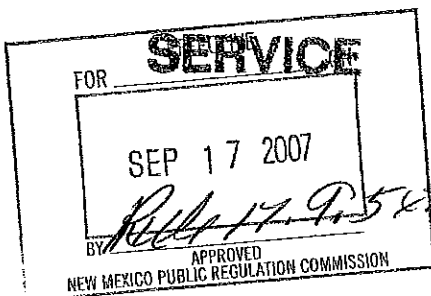
All bills under this rate are due and payable when rendered, and become delinquent twenty (20) calendar days after the billing date.

TERMS AND CONDITIONS:

Capacitors must be installed and maintained on all three-phase motors as a condition of service. They must be sized according to the horsepower rating of the motor(s) as per the following table. X
